INFORMATION CLAUSE PROCESSING OF PERSONAL DATA

When fulfilling the information obligation referred to in Article 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 (hereinafter "GDPR"), we indicate that:

- 1. The administrator of your personal data is Alter Art Festival sp.z o.o., ul. Kazimierzowska 14, 02-589 Warsaw, entered into the National Register Court Register at the District Court for the Capital City of Warsaw in Warsaw, XIII Commercial Division of the National Court Register under KRS number: 0000227624, NIP: 5862141557, REGON: 220015184 (hereinafter: "Administrator").
- 2. Your personal data will be processed for the following purposes:
 - a) Granting rights to persons authorized to enter the Event Venue on the date of signing the statement.
 - b) Establishing contact with you through the territorially competent Poviat Sanitary and Epidemiological Station or other competent sanitary services in case of detection that a person infected with the SARS-COV-2 virus participated in the Event.
- 3. The administrator processes your personal data: name and surname, date of birth, telephone number, as well as the personal data of a specific category of having or not contained in the content of your declaration symptoms of SARS-COV-2 virus infection, being placed under quarantine or isolation, and on contact with people under quarantine or isolation or suspected of being infected with SARS-COV-2 virus. The administrator may also verify the declaration of EU possession Covid UCC certificate or covid-19 vaccination certificate due to the obligation to comply with the limits on maximum number of participants in mass events. For these purposes, it may require the presentation of at least one of the above-mentioned documents.
- 4. The legal basis for the processing of your personal data listed in point 2a above is the legitimate interest pursued by Administrator (Article 6 (1) (f) of the GDPR) and the necessity to process the above-mentioned data in order to fulfill the legal obligation incumbent on The administrator referred to in point 2b above (Article 6 (1) (c) of the GDPR). The legitimate interest of the Administrator is the need to collect and process data of participants of an event carried out during an epidemic emergency, in accordance with applicable provisions of law.
- 5. Your personal data may be transferred only to the epidemiological supervision of the territorially competent state The Poviat Sanitary Inspector and the services subordinate to him, including the Poviat Sanitary StationEpidemiological. The administrator will not transfer your personal data to third countries.
- 6. Your personal data will be stored by the Administrator for a period of 14 days from the date of their collection.
- 7. You have the right to access your personal data and the right to rectify, delete and limit their processing, object to their processing on the basis of a legitimate interest, as well as to request the transfer of this data to another administrator in accordance with applicable regulations,
- 8. You have the right to lodge a complaint with the President of the Personal Data Protection Office, Stawki 2 street, 00-193 Warsaw.
